## Sewer Main Re-lining on Caledonia Road from Corby Avenue to Rogers Road

**Contract:** 16TW-OS-21CWD

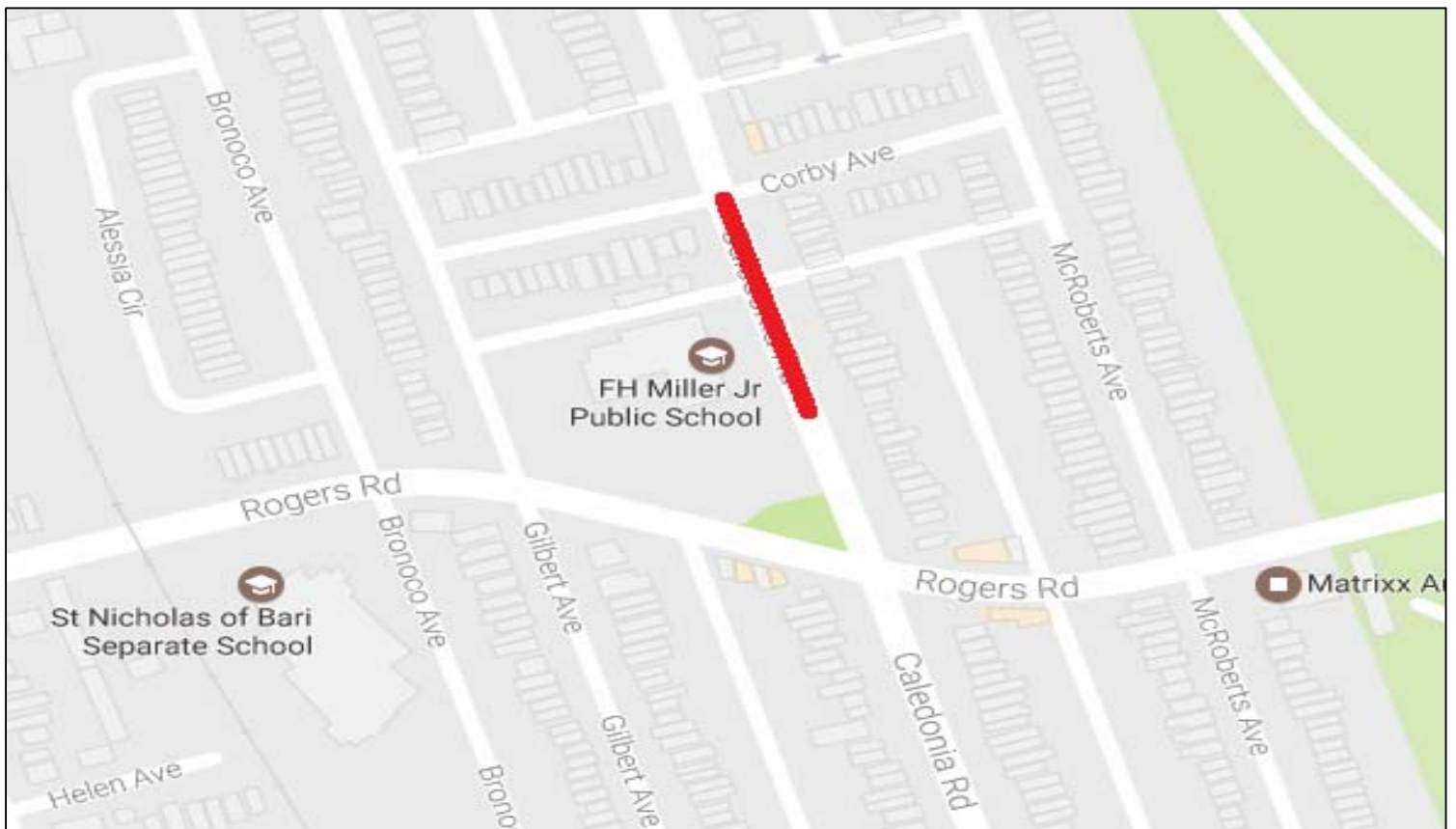
**Construction Period:** April 3 - April 28, 2017

**Anticipated Construction Duration:** 1 day

*\*Timeline is subject to change.*

The City of Toronto will be structurally re-lining the sewer main in your area between April 3 - April 28, 2017. This project is part of the Council-approved 2016 Capital Works Program to renew our aging infrastructure, reduce the risk of leaks, and ensure continued long-term reliable sewer service.

## WORK DETAILS






Re-lining of the sewer main will involve:

- Flushing the sewer with high pressure water to remove any debris.
- Inspecting the sewer with a closed circuit TV (CCTV) camera to verify that it has been adequately cleaned.
- Inserting a structural liner that will adhere to the existing pipe to form a new pipe wall. This is called a cured-in-place pipe.
  - \* During this time, the connection between your private sewer pipe and the City's sewer will be temporarily sealed and you will be asked to limit your water use.
  - \* The City-hired contractor will provide you with more information regarding this service disruption 48 hours before construction is scheduled to begin.
- Once the liner is cured, your sewer connection will be unsealed and the sewer main will be re-inspected to ensure it is fully operational.

Of note: Access to the sewer is made through maintenance holes on the street; in most cases, excavation is not required. Should the CCTV uncover the need for localized pipe repairs that require excavation, the area will be restored with sod and/or asphalt once construction is complete.

## WHAT TO EXPECT DURING CONSTRUCTION

	<p><b>Work Hours:</b> Work will take place from 7:00 a.m. to 7:00 p.m., Monday to Friday. Please note that work may extend past 7:00 p.m. in special circumstances (e.g. if the pipe liner needs more time to cure). Note: Work will not take place on statutory holidays.</p>
	<p><b>Access to Your Property:</b> Access on your property is not anticipated. If access is required in special circumstances (dye testing to verify service connection, etc.), the City-hired contractor will contact you directly to arrange for access.</p>
	<p><b>Sewer Service Disruption:</b> The contractor will need to temporarily seal/plug the private portion of your sewer pipe in order to complete construction on the City's sewer main. During this time, you will be asked to limit the amount of water you use in order to avoid a sewer back up. This includes avoiding activities such as laundry, using your dishwasher, having a shower or bath, and limiting the number of times that you flush your toilet. The service disruption may last 6 to 12 hours. The contractor will supply you with a notice 48 hours before construction begins that outlines when the disruption will start and the expected time of completion.</p>
	<p><b>Noise:</b> You may experience intermittent noise and vibration during construction (from vacuum trucks, power generators, air compressors, etc.). All work will comply with the City of Toronto's Noise Bylaw.</p>

	<p><b>Odour:</b> You may experience short-term odours while the sewer is being flushed and re-lined.</p> <p><b>IMPORTANT:</b> Drain pipes are designed to retain water after use to help create a barrier that prevents odour from entering your home (see illustration to the left). Once you receive the contractor's 48-hour notice that work will begin, it is recommended that you pour at least one litre of water down every drain (i.e. sinks, showers, bathtub, floor drains) to ensure this barrier is present.</p> <p>If odour does enter your home due to a dry drain or private plumbing issues, opening windows, etc., and pouring a few litres of water into your drains will help to alleviate this odour. Should you have any questions about odour, please contact the Field Ambassador listed at the end of this notice.</p>
	<p><b>Road and Sidewalk Access:</b> In order to complete the work in a safe manner, there will be road and sidewalk restrictions within the construction work zone. Access for emergency vehicles will be maintained at all times.</p> <p><b>Driveway Access:</b> Typically, driveway access will not be restricted. If temporary restrictions to your driveway are necessary, the contractor will notify you directly in advance of the work.</p>
	<p><b>Traffic Management:</b> Efforts have been made to manage traffic in the area for the safety of workers, road users and residents. Road users should expect delays and increased traffic on nearby main and side streets.</p>
	<p><b>Parking:</b> Parking in the active work zone is not permitted due to space requirements for construction equipment and materials. If your parked vehicle affects the construction work, it will be re-located with no charge to the owner. If your vehicle is moved, please contact parking control for its location at <b>416-808-2222</b>.</p> <p>You may park outside of the inspection work zone. City Parking Officers will be advised not to issue tickets for "Parking in Excess of 3 Hours" on affected streets. Tickets will be issued for all other violations, such as parking too close to a corner or fire hydrant and other restricted areas.</p>
	<p><b>Garbage &amp; Recycling:</b> Please follow your normal routine. If required, the contractor will move bins to an appropriate location and return them. <b><i>Please ensure that you label your bins with your address.</i></b></p>
